Grant of Options

The Company advises that it has granted a total of 8,000,000 options to two senior executives. Half of the options are exercisable at 20 cents each and vest after one year, and half are exercisable at 25 cents each and vest after two years. For each employee the options lapse after five years, or within one month of the cessation of employment, should that occur earlier.

The options have been issued under the MIKOH Employee Share Option Plan, as approved by shareholders at the 2007 Annual General Meeting.
